

**YOU MATTER 2
WAIVER AND RELEASE AGREEMENT**

I, _____ (Participant), being of lawful age and in consideration of being permitted to participate in the Homewood-Flossmoor Juneteenth Festival as a vendor described in further detail below, agree to release and forever discharge You Matter 2, its staff and/or volunteers from all manner of actions, causes of action, claims and demands for, or by reason of, any injury to person or property, including injury resulting in the death of the participant, which has been or may be sustained as a consequence of my participation in the activity described below, and notwithstanding that such damage, loss or injury may have been caused solely or partly by the negligence, except gross negligence, of You Matter 2, its staff and/or volunteers.

Should I become incapacitated, I also grant permission and authorization to the sponsors, chaperones, staff, volunteers, and small group leaders to seek and obtain such emergency care, first aid, or medical treatment as may be necessary in the event I should be injured or become ill for any reason, at my expense.

Should I become incapacitated, I hereby authorize the licensed physician, emergency medical professional, hospital or other medical or health care facility to treat me and perform all procedures deemed medically advisable for the purpose of attempting to treat or relieve any injury I receive.

I understand that I will not be permitted to participate in the Juneteenth Event and activities described below unless I sign this Agreement.

Details of the Activity

The Homewood-Flossmoor Juneteenth Festival shall include but are not limited to, the following activities: stage performances, vendor services, food trucks and services, inflatable slides, and/or participating in events/activities at and on the parking lot surface of Homewood Flossmoor High School. Should a vendor choose to set up a canopy tent it must be under the following conditions:

- To purchase 4, 25lb tent weights from the festival organizers
- Provide weights for their tent with at least 25lbs per leg
 - Vendors will not be permitted to set up until their weights are checked by a festival official
 - If the weights are below 25lbs the canopy tent cannot be used

I acknowledge and agree that I have carefully read this Agreement, that I fully understand this Agreement, and that I am freely and voluntarily executing this Agreement.

This Agreement will be governed by and construed in accordance with the laws of the State of Illinois.
